

南加州众地方召会带领弟兄们 致当地众召会里众圣徒的公开信

二〇〇六年十月二十一日

致南加州众地方召会中亲爱的圣徒们：

愿恩典与平安从我们的主耶稣基督繁增的归与你们。

本函署名的弟兄们，都是在南加州众召会中带领的弟兄们，我们发出此函是要肯定表达，我们完全赞同主恢复中相调同工们最近所发布的一篇声明，题目是：“致主恢复中众圣徒和众召会的警告—关于朱韬枢以及推广并传播他分裂之教训、出版、实行和观点的人”（二〇〇六年十月一日）。对相调同工们因着朱韬枢和一些他的同工们在主恢复中分裂的工作，而对他们采取隔离检疫的这一严重行动上，我们随同全地绝大多数的地方召会共同表明，我们与相调同工们是一。在这些日子里，我们也盼望借着强调相调同工们在该项声明中的一些事项，加强你们的信心，并鼓励你们的心。

对于朱韬枢和他的一些同工们所作的指控，我们在南加州的众召会如此响应：（一）强烈否认我们是一个由相调同工们所统领之全球组织的一部分；我们只不过是宝贝并跟随这些同工们而已，他们在倪柝声弟兄和李常受弟兄的职事所实化的新约职事中，坚定持续的继续往前。（二）强烈否认我们是以水流职事站为总部，而受其控制；我们只不过是支持其工作，并从其服事得着益处；（三）强烈否认我们是所谓“职事的召会”而不是地方召会；我们只不过是坚守主恢复中那建立并建造众地方召会的一般职事。（四）强烈否认我们被迫实行统一与划一；我们只不过是例常使用诸如“晨兴圣言”的文字材料，并参加一年七次的“节期”（国际特会和训练）。（五）强烈否认我们排外，不接受基督的真信徒与我们有交通；我们只不过是拒绝接受基督教走样的教训和堕落的实行。朱韬枢和拥护他的人所作的一切指控是不实的、侮慢的，当为我们众人所拒绝。

我们南加州的众召会着重的见证：（一）我们完全接受倪柝声弟兄和李常受弟兄的教训为时代的职事，这职事将时代的异象传输给主的儿女。（二）我们寻求并倚靠基督身体里那些是真正地方召会的众召会共同的交通，这些召会实行地方行政，尊重地方界限，承认身体的一，并以基督为独一的元首。（三）我们接受在我们中间新约职事里相调同工们的领导，因为这些同工们在配搭里并在交通的和谐里调为一团，以合乎神经纶之使徒和新约职事的健康教训，忠信的带领我们。（四）我们认为李弟兄在他一生晚期所释放的高峰真理，是我们在日常生活中可以经历的，也是建造基督身体并预备新妇所不可少的。（五）我们竭力实行神所命定、合乎圣经的传福音并牧养之路，使召会作基督的身体得以生机的尽功用、扩增并长大。

李常受弟兄离开我们以后的这些年，朱韬枢借着一些在他本地拥护他的人，在南加州一些华语圣徒中间流传含有他信息的书籍和录音带，企图发挥他的影响力。一些受影响的人参加了朱韬枢在克利夫兰的训练。另有些人因着接受了分裂的教训和异议的观点，开始对南加州他们所属的召会不满。朱韬枢和拥护他之人的活动，虽然不普遍，并且在被发现后予以制止，却有狡猾的影响，暗中破坏众召会内部和众召会中间的同心合意，并且削弱众圣徒对当前主恢复之领导的信心。目前在南加州地区众召会中，仍然有人传布朱韬枢的观点和作法。因此，我们力劝众圣徒，要留意那些推动朱韬枢教训和实行的人，停止接触那些带着异议和分裂之细菌，具有传染性的人。我们都该记住，一点面酵能使全团发起来。

（林前五6。）我们力劝众圣徒，不要读朱韬枢和他的拥护者所出版，无论是印刷或电子形式（网络、电子邮件等）方面的著作。这样的材料无可避免的，会以属灵的疾病和死亡传染给无辜的信徒。最后，就如前面所提及的同工们的警告声明，我们劝戒众圣徒们不要对当前分裂的光景保持中立，并且在对付这件事时，要胜过所有天然与个人的情感。


我们这些受托照管神群羊的监督，愿意为南加州的众召会做醒，使其蒙保守脱离任何分门结党的活动。我们祷告，愿众圣徒借助于身体里正确的交通，能对现今的情势有清明的眼光，并能以正确的辨识面对此情势。就着这事，我们推介你们阅读由同工们所发布的三份文件和警告声明：“致主恢复中众圣徒的特别交通—关于二十一位相调同工们于二〇〇五至二〇〇六年间写给朱韬枢弟兄的信函”、“对付主恢复中当前风波之路”（摘录取材自李常受弟兄出版的职事，论到主恢复当前的情势）、以及“朱韬枢和他一些同工之不同的教训与异议的观点”。这四份文件均揭示于www.afaithfulword.com/statements/index.html。为着主恢复的见证并为着主恢复所持守的真理，我们一直需要坚固、不可摇动。我们该受提醒，我们并不是与血肉之人争战，乃是与诸天界里那黑暗的邪恶属灵势力争战；我们借着各样的祷告穿戴神全副的军装，站住抵挡其诡计。（弗六10~18。）我们也必须记住并信靠这事实：我们乃是在“主的”恢复里，而祂这位信实者将维系且保护祂的恢复，如同祂眼中的瞳人。（亚二8。）


